Key Dates for Businesses

28 April 2017
Quarterly BAS (March) due if lodging via paper form

11 May 2017
Quarterly BAS (March) due if lodging via the ATO Business Portal

15 May 2017
Tax return lodgement due for all other entities that did not have to lodge earlier

21 May 2017
Monthly BAS (April) due

26 May 2017
Monthly BAS (March) due if lodging via Crosby Dalwood

28 May 2017
Fringe Benefits Tax annual return due

Superannuation Reforms

The countdown to super reform has begun, with new rules set to take effect on 1 July 2017. If you haven't thought about how your super might be impacted by the changes, now's the time to get ready. Here are some of the more important changes you need to know about.

In last year's Federal Budget, the government proposed a wide range of reforms to Australia's superannuation system. In fact, these are the most significant changes to super of the last 10 years. Although not all the proposals have been legislated, some significant ones were passed by parliament late last year and are due to take effect on 1 July.

Small Business Depreciation Concessions Ending

Just a reminder to our small business clients that the depreciating assets \$20,000 immediate write off is scheduled to come to an end on 30th June 2017.

This concession has been available to businesses with an annual turnover of less than \$2 million using the simplified depreciation rules for the last two years. Unfortunately to date there has been no sign that the Taxation Office plans to extend this concession.

A reminder that in order to be able to claim the concession, the asset must be installed and ready for use by 30th June 2017. Payment can be made at a later date, but the asset must be able to assist in producing income prior to 30th June.

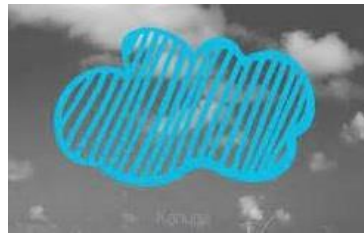
